

Guidance of Writing for BIDAN PRADA Journal

1. Articles should be the results of researches and or community services.
2. Articles have not been published yet in other journals or media.
3. Articles can be written in either Bahasa Indonesia or English. All articles are typed in font of Times New Roman 12, 1,5 spacing, and on A4 paper.
4. Articles should consist of 10 to 15 pages, excluding the bibliography and tables.
5. All articles should be sent in both hardcopy and softcopy formats (Microsoft Word).
6. Articles should be written in a form of essay and consist of the following:
 - Title
 - Abstract
 - Introduction
 - Literature review
 - Research Methodology
 - Results and Discussion
 - Conclusions and suggestions
 - Bibliographies
7. Titles should be written up to 18 words, describing the contents of the articles in concise and informative statements.
8. Abstracts should be written in either Bahasa Indonesia or English, based on the language used in the articles. The length is about 150 – 200 words, giving concise and clear statements of the articles. Type key words up to 5 words.
9. Name(s) of author's should be completely written without attaching academic degrees or other attributes.
10. Titles and subtitles should be written based on the following format:
 - A. (uppercase with dot)
 - 1. (number with dot)
 - a. (lowercase with dot)
 - 1) (number in a closed round bracket without dot)
 - (a) (lowercase in round brackets without dot)
11. Tables, Graphics, Figures, and photographs should be numbered and provided with titles, and when necessary be attached in “*jpg*” formats, with no edge lines, and be in black and white.
12. Bibliographies are written using the following order:
 - Books: author's name(s), date, title (in italic), edition, publisher, and place of the publisher.
 - Articles in a book: author's name(s), date, title of the article, title of the book (in italic), editor, edition, publisher, and place of the publisher.
 - Articles in a journal: author's name(s), date, title of the article, name of the journal, edition, and publisher.
 - Articles in seminars/conferences: author's name(s), date, title of the article, name of the seminar/conference, organizer's name, place, and date of the seminar/conference.

13. Authors whose articles are published should compensate Rp 300,000.00 (for inside Indonesia) and Rp 500 thousand (for outside Indonesia). All these fees are compensated for publishing and delivery costs.
